### STATEMENT

On 1-17-15 at 1256 hours, Judy Lee Prochnow 101852 of 1055 Ramsdell Drive called 911 to report seeing three dead bodies inside the residence of 1051 Ramsdell Drive. She discovered the bodies after going to check on the family and packages that were left on the front door steps. Judy saw the bodies through the front living room window. Sgt. Dahlstrom, Officer Keeler, Officer Becker, and myself responded to the call. Medics were requested to stage nearby.

I arrived on scene just after Sgt. Dahlstrom and Officer Becker who were approaching and checking the front of the residence. I was advised by Sgt. Dahlstrom that there were three dead bodies laying

on the living room floor of the home. I was instructed to check the rear of the residence for any signs of forced entry. The back yard is fenced in with a chain link fence and the gates were closed but not locked. As I entered the backyard, I did not see any fresh foot prints in the snow other than animal tracks. All windows including the window well basement windows were all closed with no signs of forced entry. The rear sliding patio door was found opened slightly (<1/4 inch) I opened the door and found that it was not locked or secured with a bar lock. When I opened the patio door, there was an overpowering odor of decaying flesh. The dining room light was on but all other house lights from this location were off. The Christmas tree lights and other strings of Christmas lights were still lit. No noises other than the dog barking could be heard inside. Other officers on scene were advised of this information. I held this position until Sgt. Dahlstrom and Officer Keeler arrived in back to enter and clear the residence

After doing a walk around of the home, I looked into the front living room window and observed three bodies laying on the living room floor. They were all badly decomposed. One adult body was laying on it's back with a black semi-auto pistol nearby. The second adult body appeared to be laying on it's stomach and/or side. Between the two adult bodies was the body of a small child. At this time, the bodies are presumed to be that of the home-owners David Timothy Crowley 070785 and Komel Rasool Crowley 112086 and their daughter Raniya Crowley (5 yoa?)

While other officers cleared the residence, I took digital photos of the exterior of the home. Afterwards, I secured the front yard with police barricade tape.

I made contacted with Judy Prochnow and her husband Collin Keith Prochnow 082848. They explained that the Crowley's moved into their residence just over a year ago. They believed it was November/December of 2013. They had very limited contact with the Crowley's who appeared to them to be a very normal family and neighbor. However, The Prochnow's noticed that David's behavior started to change. Late in the fall of 2014, David began wearing military type clothing frequently and cut his hair in a Mohawk style. They also mentioned that the Crowley's almost always have the drapes pulled down on their living room window. They though it was unusual that the drapes were up recently for such an extended period of time. The Prochnow's believed they last saw the Crowley's just before Christmas.

I also made contact with Brett Thomas Malay 070785 and his wife Katlin Theres Malay 112486 who reside at 1048 Ramsdell Drive. They had no information to offer at this time other than to say they last saw the Crowley family sometime just before Christmas. They had not seen any activity since then.

I later assisted with crime scene protection at the rear of the residence until I was cleared to leave by Sgt. Dahlstrom.

## STATEMENT

On January 17, 2015, I assisted officers with a suspicion call at 1051 Ramsdell Drive. A 911 caller reported seeing dead bodies in the residence. I responded to the scene and was met by the male complainant in the driveway east of the house. He pointed to the front of the house and told me they were in the living room. I approached the house from the east side and looked in the window.

I noticed several obviously dead bodies lying on the floor, near the front picture window. I noticed a black handgun on the floor as well. Lastly, I noticed a medium sized dog barking and running among the bodies. I advised dispatch of my findings and requested the channel be restricted to emergency traffic. I then took up a position on the west side of the residence and waited for backup to arrive.

Officers J. Broughten and Becker arrived a short time later. I advised them of my findings. At that point, we could all smell the odor of decaying bodies. I remained in the position and Officer Broughten went around the back. A short time later, he advised the back sliding glass door was unlocked and ajar. I asked him to hold that position and Officer Keeler indicated he would respond. I also asked for CSO Brian Booth to respond to help us catch the dog.

Officer Becker took up a position in the front of the house until Officer Keeler arrived. Upon his arrival, we approached the rear sliding door along with CSO Booth. We opened the door and lured the dog outside where it was captured. Officer Keeler and I conducted a protective sweep of the residence, looking for additional victims or hazards.

As we entered the residence the decay smell was overwhelming. I noticed dog feces all over the floor. We checked the garage first, then the main level, and lastly the basement. On the main level, in the living room we located three decaying bodies; two adult and one child. All were heavily decayed. [REDACTED] I noticed several bloody foot prints on the floor, in the area between the kitchen and living room. We left the area undisturbed and left the residence.

I posted officers to secure the scene and requested that CSO Booth start a crime scene log. I asked him to write down every person who entered scene.

I then requested dispatch contact our detectives and the BCA. Lastly, I contacted Captain Bermel and provided him with a synopsis of what I knew at that point. I remained on scene and coordinated exterior security until I was relieved by Sgt. Gummert and Captain Bermel.

## STATEMENT

APPLE VALLEY POLICE DEPARTMENT Supplement Report Case File #15000303 Officer: T. Becker #4920 Date: 1-17-2015

On 1-17-2015 at 1259 hours Officer J. Broughten and I were dispatched to 1051 Ramsdell Drive on a report that the neighbor saw dead bodies inside of this residence. The caller, Judy Prochnow, stated that there were dead bodies on the floor inside of the residence and that she saw a gun on the floor.

Sgt. Dahlstrom was the first on scene and met with some neighbors. Upon my arrival I observed Sgt. Dahlstrom walking away from the front of the residence. Sgt. Dahlstrom advised me that there were in fact 3 deceased parties that could be seen from the large picture window at the front of the residence. There was also a dog inside of the residence. Arrangements were then made for Officer Keeler and CSO Booth to respond to the residence.

While waiting for those officers to arrive, Officer J. Broughten began taking digital photographs of the exterior of the residence and a short time later Officer J. Broughten observed that the rear sliding glass door was ajar. CSO Booth was then able to coax the dog out of the residence while Sgt. Dahlstrom and Officer Keeler did an immediate sweep of the residence while Officer J. Broughten and I maintained the perimeter of the residence.

While on scene I took digital photographs of the residence including the nearby neighbor's residences as well. I also located a mailbox stationed to the east of the residence and took a digital photograph of the mailbox labeled 1051 that belonging to the residence in question. I opened the mailbox and found a very full mailbox and removed a piece of mail that contained the name David Crowley. I also found another piece of mail in the name of Komel Crowley. All of the remaining mail was left in the mailbox. The postmaster was arriving at this time and handed me today's mail which was placed inside of the mailbox.

I then spoke to Lorry Tupy who resides at 1047 Ramsdell Drive, one house east of the Crowley residence. Tupy indicated that she had not seen any of the 3 residents at the Crowley home for over 3 weeks. Tupy stated that the male party that lived there was David and that he had a young daughter who was approximately 5 or 6 years old and her name was Ranita. Tupy could not recall the wife's name but stated that she believed that she was East Indian. Tupy stated that her husband, Larry talked to David much more often than she did but he was not available due to being at their cabin up north. Tupy stated that the Crowley's were brought to her attention today when her other neighbor, Collin Prochnow came over and asked if she knew where the Crowley's might be. Tupy stated that she thought that they had possibly gone to Texas for the holidays and just weren't back

yet. It was then that Tupy volunteered to call David's cell phone to see where they were as a last ditch effort to get into contact with them. Tupy stated that she then used her land line, 952-432-8574 to call the cell phone that she had on record for David, 254-616-0461. Tupy stated that the phone was right to voicemail and she did not leave a message. Tupy stated that she had begun to walk across the yard connecting her house to the Crowley's in the snow when she was informed by the Prochnow's that she should probably turn around based on what they had seen inside.

Tupy stated that she knew David to be somewhat of an artist in that he was doing some work with screenplays and films and had told her husband that he had sold a screenplay and was working with some lawyers and that it had something to do with guns and gun control and or possibly the gun industry. Tupy also indicated that she had observed David to be moody at times stating that sometimes he was very friendly and other times he would appear to try and avoid any contact. Tupy could not pinpoint a time when she last saw all of the Crowley's. I did take digital photographs of the shoes Tupy was wearing when she walked from her residence to the front stoop area before being informed by the Prochnow's that it would probably be best that she return to residence. Those photographs have been uploaded to Apple Valley Police Department secure server for future use if needed. I took a digitally recorded statement from Tupy and it will be uploaded to the Apple Valley Police Department secure server for future use if needed.

I then spoke with Collin Prochnow at his residence of 1055 Ramsdell Drive. Collin indicated that he heard and saw the dog inside of the Crowley residence early this morning and thought it unusual since he had not seen anyone come and go from the Crowley residence. He conferred with his wife, Judy and she made mention to him to check to see if the Christmas presents that were on the front stoop were still there. Collin then went outside and noted that the Christmas presents that they had observed being on the front stoop on January 10, 2015 when they left to go to the airport were in fact still on the front stoop today. Collin stated he then walked over to the residence and had observed that the presents were actually scattered about and he picked them up and stacked them back up. Collin then checked inside of the front picture window and observed what he thought to be dummies. Collin stated that he now knows that they were the bodies of the deceased but initially he thought that they were dummies or some type of props that were left in the residence to appear as though they were home when they weren't. After looking inside of the residence Collin then went back to his residence, told his wife Judy about what he had seen and then she confirmed that they were deceased persons and immediately called 911.

I took a digital recorded statement from both Judy and Collin Prochnow and they have been uploaded to Apple Valley Police Department secure server for future use if needed.

It should be noted that in speaking with Collin he did indicate that at some time between December 2nd, 2014 and December 19th, 2014 he awoke between 1:00 a.m. and 2:00 a.m. to the sound of gun shots. Collin attempted to narrow down when he had heard the gun shots and estimated that it may have been on December 9th or 10th. Collin did not contact law enforcement but stated that he checked out his front door and didn't see anything and checked out the back of his residence and thought it was fireworks. Collin states that he did hear the gun shots from the area of the Crowley residence. Collin also indicated that he noticed a big change in David's appearance sometime in

September 2014. Collin stated that he believed that David was ex-military and had quit a few tattoos but most alarming to him was that he observed that he only dressed in Army fatigues and had shaved his head into a style of a Mohawk. Collin indicated that they never had a conversation about his appearance change but they still had friendly contact after this change in his appearance in the September / October months of 2014.

I also spoke with Annemarie and William Hixson at their residence at 1052 Ramsdell Drive. Annemarie stated that she does not know much about the Crowley family and could not give me any names of anyone that lives there. She only indicated that a white male lived there and that he appeared to be a good father to their little girl who was approximately 5 years old. Hixson did indicate that she has noticed that there is a certain light or candle that has come on every day since Christmas. I did not take a recorded statement from either Hixson party due to their limited information.

I attempted contact at 1048 Ramsdell Drive to follow up with Malay's but they were no longer at the residence.

On 01/17/2015 at 1259 hours, I was dispatched to assist officers on a report of dead bodies located inside a residence at 1051 Ramsdell Dr. A neighbor reported to dispatch going over to check on the family who lives at 1051 Ramsdell and seeing dead bodies along with a gun laying on the floor through the front bay window.

Upon my arrival on scene, I met with officers Becker, Broughten, and Sergeant Dahlstrom. Sergeant Dahlstrom said he looked in the front bay window and saw three bodies laying on the living room floor along with a gun laying on the floor. Sergeant Dahlstrom also said there was a dog running around inside and barking. At this time, the decision was made for officers to enter and clear the residence based on exigent circumstances. Officer Broughten reported the sliding glass door in back of the residence was not locked.

The dog inside the residence was barking at officers through the sliding glass door in the back. It appeared to be aggressive. CSO Booth responded with dog treats and a catch pole. I opened the sliding glass door and the dog was given some treats inside the residence. The dog continued to bark and it took approximately 5 minutes for it to come outside. Once it came outside, CSO Booth used his catch pole to secure the dog and put it in his truck. Sergeant Dahlstrom and I then made entry into the residence through the sliding glass door in the back.

Prior to entering the residence, I announced officers presence. There was no response. Sergeant Dahlstrom and I cleared the main level of the residence including the garage. In the living room, I noticed there were three bodies obviously deceased laying in close proximity on the living room floor. Two of the bodies appeared to be adults and the other a young child. I also noticed a handgun laying in close proximity to the bodies. [REDACTED]

Sergeant Dahlstrom and I then cleared the basement. There were piles of dog feces all over the floor on both levels of the residence. In the basement I noticed military equipment, guns, and ammunition.

In the basement bedroom I noticed military clothing along with more military equipment, gun cases, and ammunition. No other people or animals were located in the residence.

Sergeant Dahlstrom and I exited the residence. Officers secured the scene until detectives arrived. I assisted with scene security until I was cleared from the scene by detectives.

On 01-17-15, at approximately 1400 hours, I received a call from Sergeant Dahlstrom advising me of the incident at 1051 Ramsdell Drive. At approximately 1500 hours I arrived at the police station, and starting assisting the other detectives. Once the warrant was signed by the judge we proceeded to the residence to work with the patrol officers at the scene.

Once at the scene, Sergeant Dahlstrom advised me of their findings. I also spoke to several agents with the State Bureau of Criminal Apprehension, (BCA) who were also at the scene. They advised me that their crime scene unit was en route, and would assist us in processing the scene. I assigned Detectives Booth and Bone to assist the BCA team with the processing of the residence.

While at the scene I assisted Detectives McKnight, Tietz, and members of the Dakota County Electronic Crimes Unit. Once the BCA processing team had completed a portion of their work processing the scene, I, along with the remaining detectives entered the home to assist in the processing. I checked the young girl's room along with Detective Tietz for evidence. I checked the master bedroom with several other detectives. I observed several glass pipes in the bathroom along with a large plastic or glass bong on the counter area of the sink. I also observed a small amount of marijuana laying on the dresser in the master bedroom.

Detective Tietz and I searched the garage of the home, as well as the basement of the home. The garage was well kept and organized. I did find a plastic tote in the trunk of one of the cars that contained gun ammunition, medical supplies, water, and an empty hand gun case. It appeared to me as if the case was going to be used for a survival kit.

In the basement laundry room I located several rifles enclosed in plastic gun cases. There were also boxes of military clothing next to the guns. In a storage area, as well as a room next to the storage area, I located several small and large plastic bottles of water. There were also numerous cans of food of various sizes. In the larger spare room area, there was additional military and police clothing. There was also several pieces of military and police equipment that appeared to be props for movie making. We also located several boxes of silver and gold coins. Based on my findings, it appeared to

me that this portion of the house was being used for stored survivalist type items. Nothing of evidentiary value was located in the basement.

All of the actual guns were taken from the scene, and brought to the police departments property room for safekeeping. Please see other detectives and officer reports for further details.

into the house and confirmed that the bodies of three deceased individuals were located inside the residence and that a firearm had been located near the bodies. I also learned that the Minnesota Bureau of Criminal Apprehension had been called to assist and that Apple Valley Officers had secured the scene.

I checked Dakota County Property records and found that the residence was owned by David T. Crowley and Komel Crowley. I also ran David and Komel Crowley's names in IIQ, Clear and various social media websites. IIQ listed David Crowley's phone number as 254-616-0461 (T-Mobile) and Komel Crowley's number as 214-470-5794 (AT&T). I also ran these numbers through Clear which listed the service providers for the numbers. On the evening of 1/17/15, I prepared preservation letters for AT&T and T-Mobile to preserve any data these carriers may have for the phone numbers listed above. I faxed the preservation letters to their respective carriers on the evening of 1/17/15.

I also assisted Detective McKnight with interviewing the neighbors that live at [REDACTED], which is the residence located just [REDACTED]. We spoke with the homeowner, [REDACTED] and his [REDACTED] both of whom said the residence [REDACTED] (1051 Ramsdell Dr. ) had been dark since around Christmas and that they hadn't seen the occupants in a long time. [REDACTED] said her room was on the back of the house and that lights on the back of the neighbor's house would shine into her room if they were on. [REDACTED] said she hadn't seen anyone at the house since the weekend before Christmas school break (which started 12/19/15). [REDACTED] said she believed the daughter had started school and that the mom was a stay at home mom. [REDACTED] said she had never heard the couple fight and that she used to see the husband out running around the neighborhood. Lastly, [REDACTED] said the mother talked about having her babysit the daughter, but that she didn't think he liked her and that he seemed like he didn't want her to babysit. Our conversation with [REDACTED] and his [REDACTED] was audio recorded and downloaded to the secure server.

On 1/18/15, I assisted with executing a search warrant at 1051 Ramsdell Dr. I assisted by searching the residence. During the search, I located an HK USP 40 handgun (.40 S&W) and a Marlin Model 60 rifle (.22) in a room in the southeast corner in the basement of the residence. Several other firearms had been located in this room earlier and moved to the basement laundry room area. The firearms were later photographed, seized and transported to the Police Department for safekeeping. A detailed list of the firearms' make, models and serial numbers can be found on the search warrant receipt. I later transported the firearms and other evidence items to the Police Department and assisted Sergeant Gummert with securing them in the property room.

## STATEMENT

On January 17, 2015 I was contacted to respond to 1051 Ramsdell Drive to assist Sgt. Dahlstrom on a crime scene. Prior to going to the scene I responded to the Apple Valley Police Department where Detective Bone was in the process of writing a search warrant for 1051 Ramsdell Drive. Sgt. Dahlstrom had advised me that the Bureau of Criminal Apprehension (BCA) had also been notified of the situation and was in route to the residence. Once at the residence I was meet by Special Agents Chris Olson, Gary Swanson, and Michael Phil (BCA). SA Olson advised me that the BCA Crime Scene team was enroute to the residence. Detective Bone had the search warrant signed and we waited until the Crime Scene team arrived. The residence had been marked off with yellow crime scene tape and CSO Booth was controlling the entry and exit of the scene and crime scene log. Detective McKnight started taking photographs of the outside of the residence and did not make entry into the residence at this time.

Once the BCA Crime Scene team arrived on scene SA Olson, Detective Bone, Joe Cooksley (BCA CS), Beth Wolf (BCA CS) and myself made entry through the unlocked patio door located on the back side of the residence. Once inside you immediately noticed dog feces all over the floors. Crime Scene Specialist Cooksley lead the group of us through the residence to make sure that none of the evidence would be disturbed. While inside the residence for this first walk through Detective Bone took the AVPD camera in and took photos of the crime scene. The front door was secure and there were no signs of forced entry.

On the initial walk through of the residence, I noticed what appeared to be two adult bodies and one child body laying on the floor in the living room area. The child's body appeared to be in a later stage of decay and was missing her right arm. The head of the child was laying between the legs of the adult female body with her head pointing west. The adult female's body was also pointing west and

was in a later stage of decay. She was laying chest down on the floor. The head of the female body could not been seen on the initial view. Also the female did not have either hand. The male body was laying on his back with his body point toward the east and both arms spread outward from the body. He was missing his right hand and had a black, semi auto hand gun several inches from his left hand. There was a small portion of his rear skull still attached to the spinal column but a large portion of the head was missing. His body was also in the later stage of decay.

The living room and dining room were an open area and there was what appeared to be blood on the flooring between the two areas [REDACTED]

[REDACTED] The Mac lap top computer on the kitchen counter was open and appeared to have power to it. The thermostat in the hallway was reading 68 degrees and there were some small spots of what appeared to be blood in the area.

Once inside the master bedroom located on the north side of the residence I noticed a small amount of marijuana and drug paraphernalia on the top of the dresser. I also noticed a small gun safe on the night stand next to the bed. The safe was open and had a set of keys inside and a semi auto magazine loaded with what appeared to be .40 cal. hallow point ammunition. In the closet of the master bedroom was a large green footlocker with a padlock on it. There were no immediate signs of any blood inside the master bedroom area.

The bedroom/office on the south side of the residence had a small loveseat, desk with a Apple computer and file cabinet inside. On the computer desk was a pad of paper and pen. The paper had what appeared to be blood on it and written in pen was "open 'The Rise' most recent version" and [REDACTED]

After the initial walk through Detective Bone, SA Olson and myself exited the residence allowed the BCA Crime Scene Team to start collecting evidence and documenting the crime scene.

While waiting for the crime scene team to complete their process Detective Bone and I went to 1048 Ramsdell Drive and spoke with Brent Malay and Kaitlin Malay. The Malay's have been neighbors who live directly across the street from the residence. Brent Malay had stated that they were not close with David, Komel or their daughter since the Crowley's moved in December of 2013. Brent stated they would wave at each other in passing, had offered his snow blower to them during a heavy snow storm, but did not socialize with them. Brent stated the last time he saw anybody at the residence was this Christmas Eve (2014). He was going to close the blinds on the front of his residence when he looked out of the window and saw David standing in the front window of David's residence. He said they looked at each other and then Brent closed his shade, while David had turned and walked away. Brent was not sure of the exact time but knew it was after dark and believed it was between 6 and 9 pm. Brent also stated he did not notice the Christmas presents on the front step until today.

Medical Examiners' Investigator Gregg Spandl and Medical Examiner Dr. Jessica Lelinski arrived on scene and was escorted into the residence by Detective Bone and myself to check out and remove the bodies inside. Dr. Lelinski did the initial check of the bodies and assisted Investigator Spandl in the collection of the bodies and body parts.

Once the BCA Crime Scene Team was finished with their processing of the scene, AVPD Detectives, DCSO Deputies and BCA SA Olson started collecting evidence. Detective Bone took photos, Detective McKnight logged in evidence in the property log, Detective Tietz, Detective Klokonos, Sgt. Gummert, Deputy Olson and Deputy Jacobson collected evidence. For details of the search see supplements.

During the search I assisted with photos, collection and supervised the search. I found the following items:

All evidence collected by the BCA was transported to their lab for processing. All electronic evidence was transported to the DCSO for processing and all other evidence was transported to the AVPD and entered into the evidence room.

Detective Bone and myself attend the autopsy's at the Hennepin County Medical Examiner's Office. During the autopsy's the Medical Examiner's located an entry and exit bullet holes into the skull of the child. They also found two entry bullet holes in the skull of the adult female and one exit bullet hole in the skull of the male adult. On 01-19-15 Detective Shane Klokonos had given me some information that a text message was sent from David Crowley's phone to a phone number of 319-360-8803 which belonged to a Christopher L. Peck, dob/02-10-89. The text message was sent at 7:22 a.m. on December 19, 2014. The text referred to what appeared to be a possible drug deal. The text messages referred to: "do you have any" and "when and where" type information.

On 01-19-15 I contacted Mr. Peck to ask him questions concerning the text messages that were sent from David Crowley's phone to his phone. Mr. Peck advised me that he has known David and Komel for several years and last saw them on December 19, 2014. Mr. Peck describes David and Komel coming to his residence on December 19, 2014 around 1:00 p.m. where they did purchase a small amount of marijuana. Mr. Peck said that he was not just David's marijuana dealer; David was his Mentor for filming and producing films. Mr. Peck went on to describe that he has known David and Komel for several years and had traveled to Oklahoma with David and Daniel Mason and Mitch Heil to help film scenes for the 'Gray State' concept trailer back in March of 2013. The group had traveled to Oklahoma where a lot of the filming was done. Mr. Peck stated that he has worked on and off with David on the project of 'Gray State'.

On December 19, 2014 around 1:00 p.m. he stated that David and Komel had come over to pick up the marijuana. When they came over they were alone and their child was not with them. Mr. Peck has hung out with the family to include August, 2014 when he attended the Crowley's daughter's fifth birthday party. Mr. Peck knows that the meeting happened on December 19, 2014 because it was just two days prior to him leaving for Iowa for Christmas and the Crowley's had wished him a Merry Christmas and a safe trip.

Mr. Peck states that the last time he spoke with the Crowley's was on December 19, 2014 and has not spoken with them since that day. Mr. Peck was very cooperative and forthcoming with his information. He even told me that I needed to speak with Daniel Mason and Mitch Heil who were also part of project for 'Gray State' and friends of David's. Mr. Peck said it has been over a year since he has seen Mitch but had just spoken with Daniel Mason the day before I spoke with him and gave me the cell phone number for Daniel Mason as 612-839-8686.

On 01-19-15 I spoke with a Daniel August Mason, dob/09-10-81. Mr. Mason's phone number is 612-839-8686. Mr. Mason advised me that he had known David Crowley for approximately four years and was one of the actors on Crowley's concept trailer for 'Gray State'. Mr. Mason became involved with Crowley when he met him through his company called Bullet Exchange. Bullet Exchange was a company run by Crowley and Heil that trained actors to be in military type movies, along with renting out props related to military and police.

Mr. Mason had stated that the concept trailer for 'Gray State' was made to help produce with what he called crowd funding. People would donate money towards the movie and concept trailer of 'Gray State'. He thought that approximately \$61,000.00 was raised to help produce 'Gray State'. Once the concept trailer was done, Crowley's intentions, according to Mason was to try to sell the movie for a full-length movie to movie studios in California. At one point in time he thought that the movie studios had come back saying it was going to run roughly \$30 million to produce a full length movie of 'Gray State'. Mr. Mason was unsure as to whether or not any actual paperwork or contracts were signed to make a full-length movie.

Mr. Mason said his involvement with 'Gray State' and Crowley was strictly as an actor and as a friend but had not been involved in any financing or was actually listed on any paperwork as a partner with Crowley and Heil.

Mr. Mason states that the last time he saw the entire Crowley family was some time near the end of August when he attending Rani's birthday party at the Crowley residence. At this birthday party was not only Mason but a lot of writers, producers and film makers who were all in some way, shape or form related to the movie and concept trailer of 'Gray State'. The only other people that he can remember that were at the birthday party, other than people related to the movie was Crowley's family, David Crowley's father and brother and were there along with possibly some other family members but Mr. Mason was unsure.

The last time Mr. Mason saw David Crowley was in September but he could not remember the exact date in September. He stated that he had come over the Crowley's residence to talk to David

concerning the movie and where the movie was heading. The talked to David out in the driveway of the residence and had stated that David had looked like he had lost a bunch of weight and was fragile. Mr. Mason stated that this was not so much uncommon for David when he would get wrapped up in his projects and writing scripts for the movie.

After the September meet, Mr. Mason states that he received an e-mail on the first of October, 2014 from David Crowley's attorney. The e-mail was asking for Mr. Mason to release any rights he had as an actor in the movie so that David could take the script and movie a different route than what was originally planned. Mr. Mason stated that he did not reply back to the e-mail that was sent by David and had taken the Release Form to his attorney's to review before signing anything for David.

On December 7, 2014 Mr. Mason states that he received an e-mail directly from David Crowley. The e-mail stated, in summary that David had decided to take the 'Gray State' into a different path than what they originally had thought and in order for him to do what he needed to do, Mr. Mason needed to sign a Release Form releasing him of his rights to the movie. Attached to that e-mail was the same Release Form that was sent on October 1, 2014. Mr. Mason stated that he replied back to David's e-mail telling him that he needed his attorney to have time to look it over before he signed any release concerning the movie. December 7, 2014 was the last contact Mr. Mason had had with David Crowley or anyone in his family.

Mr. Mason had asked me if I had talked to Mitch Heil yet concerning David Crowley. I advised him that I had not and Mr. Mason gave me Heil's phone number so that I could contact him. Mr. Mason stated that he believed that David Crowley and Mitch Heil had dissolved their partnership in the business but believed that that had happened on good terms. He thought that that had happened around the September/October time frame of 2014.

Mr. Mason described David Crowley as a very loving man towards his family and loved his family more than anything else in the world. He also stated that he was a very artistic individual, did not show any signs of violence and was not an extremist. Mr. Mason says that David had always been upset about the way he was used in the military during Iraq and Afghanistan but was not an extremist.

He also stated that he knew that David believed in the higher power when it came to religion but they never spoke about religion. David never talked about Christianity, Muslims, Islamic beliefs or any other type of religions out there. If anything, Mr. Mason thought that they may be atheist.

Mr. Mason left the door open for any further contacts by telling me that I could contact him with any further questions. I also left Mr. Mason my phone number to contact me in case there anything else he remembered about Mr. Crowley that he thought would be important for to know.

current state of affairs that were going on around the world and how unhappy they were about it. Mitchell said that David was not anti-government; as a matter of fact, David had spoken at a Ron Paul support rally and was not happy with the bickering and arguing between Republicans and Democrats but he was far from being anti-government.

Once out of the military David and Mitchell had attended film school together. Once they graduated from their film school, they had started up two different companies. The first was called Hot Head Productions. Hot Head Productions was responsible for filming commercials, music videos and was also the production company that was being used to film and produce the movie or trailer for 'Gray State' project. The second company they started was called Bullet Exchange. Bullet Exchange is a company that they started where they rented props and trained actors to be able to move fluently while acting during military movies so that it looked as if they were truly in the military. According to Mitchel, Bullet Exchange was not a successful company and they did not make much money towards that.

In 2010 they started Gray State LLC which was also connected to the Gray State 'The Rise'.

The two had helped make the concept trailer together for the 'Gray State.' After the concept trailer had been completed and they started trying to sell the movie to movie producers, in late 2012, Mitchell said that they broke off from the project. According to Mitchell, David had started taken the movie in a totally different direction than even the commercial trailer was showing. He started digging more into the conspiracy theories and taking the moving into a totally different direction. According to Mitchell the concept trailer and the actual movie were going to be completely different. He also stated that David started working on a documentary and started talking about a min series concerning the project. Mitchell stated that he needed to be able to make some money and thought that he wasn't seeing the bigger picture that David was seeing concerning the movie. 'Gray State' was David's project to begin with so Mitchell totally separated from 'Gray State' giving all rights to David concerning the project.

Mitchell described David as becoming all completely consumed with 'Gray State.' That was the only thing he was focusing on and that wasn't focusing on finances and other things concerning their business. For that reason, that is why Mitchell separated from the 'Gray State' project. At the time of the separation, 'Gray State' was not bringing in any money. The concept trailer that was produced raised some funds to create a documentary that David was editing. Mitchell advises that he helped on some of the documentary interviews but he has never seen a finished product concerning the documentary that David was editing and that was David's responsibility. David would not let Mitchell see it until it was completely edited. As far as he knew, it had not been completely edited but knew of a three hour long version, unedited, of the documentary out there that existed.

According to Mitchell, David got very involved in his research concerning the 'Gray State' project. The movie went so far away from the concept trailer, it started going heavily into the conspiracy of killing people and that David was so wrapped up in his research and people that he was speaking too, he became distant from Mitchell and the company.

According to Mitchell, on September 24, 2014, Mitchell had signed over all of his rights in reference to Hot Head and Bullet Exchange LLC to David. He had legally signed over all rights to David and was no longer part of those companies. Mitchell felt that the only way to save their relationship as friends, was to separate business and friendship. David was getting so involved in the 'Gray State' project that his health was deteriorating.

Mitchell stated that in September when he signed over all the rights was the last time he physically saw David. He had gone over to David's residence to meet with him and David came out and wouldn't let him inside the residence and they only spoke in the driveway. At that time, while speaking in the driveway, David had physically and mentally changed according to Mitchell. His physical appearance looked frail and he wasn't talking like the David that Mitchell knew. According to Mitchell, David was not an alcoholic or huge drinker. He would drink periodically but when he would drink, he would drink to get drunk.

Mitchell said that David and Komel had met while in Texas and when they met, Komel was Muslim and had converted to Christianity so that she and David could get married. Mitchell said that he knew that when David was growing up, his family was religious and had gone to church and it was Christianity but was unsure whether or not it was Catholic or some other religion. He stated that Komel had given up her Muslim status for David and knew that her family was not happy about that. David did not speak about religion in conversations; nor have any kind of arguments or debate concerning religion it just was not a subject that came up often between Mitchell and David. Mitchell also described David as a great family man, awesome around his family and loved them very much. Mitchell was concerned that David became wrapped up in his research but could not give any further insight concerning the situation and death of the Crowley family.

Mitchell agreed to speak later if I had any follow-up questions. His statement was recorded on my digital recorder and later downloaded onto the secure server at the Apple Valley Police Department

On 01-20-15 Sergeant James Gummert and I responded to [REDACTED] at the address of [REDACTED] to speak with a Michelle Marie Wallick, the [REDACTED] the [REDACTED]. Ms. Wallick had advised us that the little girl that they knew as [REDACTED] actual first name is spelled [REDACTED] had been attending their school since the fall of 2014. [REDACTED] was dropped off every single day by both of her parents, her mother and her father, and picked up at the end of the school day around 3:00 p.m. also by both of her parents on a daily basis. [REDACTED] never missed school, was always attentive and was described as an extremely bright and smart young lady.

[REDACTED] was in what would be considered kindergarten at the school and her normal school day was from 8:15 a.m. to 3:00 p.m., Monday through Friday. The last day of school that [REDACTED] attended was on December 19, 2014 which would have been a Friday. That was the last day of school prior to the Christmas break and then school resumed back on January 5<sup>th</sup>, 2015.

Ms. Wallick stated that when [REDACTED] did not show up for school after the Christmas break, there were several voice mail messages left for both [REDACTED] asking if [REDACTED] was going to come back to school.

Ms. Wallick described the parents as somewhat of loners. They would always stand off together, off to the side every day when they would pick up [REDACTED] from school and never socialized or spoke to any of the other parents or staff members when they were picking up [REDACTED] from school. Ms. Wallick did describe [REDACTED] as a very sociable person when it came to one-on-one with [REDACTED] teacher. Any communication with the family always went through [REDACTED] and not any communication with [REDACTED]. When it would come to conference time, [REDACTED] would be the only one who would show up for conferences and [REDACTED] never did.

The only issue that Ms. Wallick could remember during the time that [REDACTED] was at their school was a time back in October, 2014 when [REDACTED] came to school some time during the school day, became very upset and tried to hide in the classroom. When the teacher found her she was cowering in a corner and crying and saying that she was afraid, so much so that she could not calm down enough and she

had to be sent to the office to calm down. Other than this one incident, there were never any other incidents at the school concerning [redacted] or her parents that stood out to the school staff.

Ms. Wallick said that [redacted] did have a very strict diet and did not know exactly what the medical term was but was advised by her mother that she had a leaky gut and had to have a strict diet for her food and water intake. Other than that one medical condition, the school did not know of any medical conditions that [redacted] had and that her doctor was a doctor out of [redacted]

When Ms. Wallick was asked about emergency contacts on [redacted] school form, she stated that the [redacted] had not advised of any emergency contacts and as a matter of fact, when they were asked about adding an emergency contact, or a list of people who would be authorized to pick [redacted] up from school, they were told that there was no family in the area that would be added as an emergency contact and that the family was alone.

Ms. Wallick, once again, described [redacted] as an extremely bright and gifted child with a great vocabulary and a fast learner when it came to reading. She loved her dog [redacted] and would constantly bring photographs into the school to show the teachers and staff her dog. Ms. Wallick was not able to give us any further information concerning the [redacted] family and advised us that if she could be at any service later on to feel free to re-contact her.

On 1-19-2015 I spoke to Sidrah Alam via phone. Sidrah is the sister of Komel Crowley. Sidrah stated she is currently residing in [REDACTED] with her mother and father. Sidrah advised me that her mother is currently in hospice care due to her aggressive form of cancer and was not expected to live much longer. Sidrah gave me the following account of her family history as well as her relationship with her sister and her brother-in-law.

Sidrah advised me that she and her sister were born in Saudi Arabia at a military base while her father worked for the US military. She stated once her father left his position with the US military they returned to live in Pakistan where her mother and father were originally born. She stated that they lived in Pakistan until her sister, Komel, turned 17 years old. Upon Komel turning 17 years old, the entire family moved to [REDACTED]. While in [REDACTED] Texas Komel got accepted to [REDACTED] and that the family then moved to [REDACTED] to be closer to Komel while she attended [REDACTED].

Sidrah advised me that while her sister was attending [REDACTED] she met David Crowley who was stationed there in the Army. Sidrah stated after dating for a period of time they eventually got married and Komel subsequently got pregnant. Prior to the birth of their child she advised me that David had been sent back to Afghanistan for a 2nd deployment. She stated while David was in Afghanistan Komel lived with them in [REDACTED]. Sidrah advised me that upon David's return back to [REDACTED] the couple eventually moved to Minnesota. Sidrah advised me to her knowledge there were no issues with David and Komel. Sidrah advised me that she would come up to visit them and had no issues with her sister during those visits. Sidrah stated that the two were quite close and talked daily. Sidrah stated there were days where they would talk 2 to 3 times a day either via phone or text. However Sidrah stated she was not very close to David. She stated she did not feel completely comfortable with him and always felt that there was some kind of distance between her and David.

Sidrah stated that in early 2014 Komel had called their father to discuss her relationship with David. She stated that her sister was under a large amount of stress because she was the sole bread winner for the family. She told her father that she wasn't sure she could stay married to David anymore because he did not do anything to help financially with the bills. Komel did advise their father that she was not being physically or emotionally abused it was just the financial struggles that made her question the marriage. After talking with her father, Sidrah stated, Komel agreed to continue working on the issues with David.



In May of 2014 Sidrah stated David and Komel came to their home in [REDACTED] for a visit. She stated that while in [REDACTED] David and Komel flew to California to sign a contract with a movie production company for David's film. Sidrah stated they watched her sister's child, Raniya, while they were in California. She stated that they both came back from California and then proceeded back to Minnesota with Raniya.

In July of 2014 Sidrah stated that their mother had been diagnosed with cancer and that her and her father had decided that she would start chemo therapy to treat the cancer. Sidrah advised me that Komel was unhappy with the fact that her mother was going to go through chemo therapy and did not believe that they should undertake chemo therapy. Sidrah advised me that over the course of the summer she learned that David did not get a contract or the contract was cancelled, she was uncertain of those details but advised me that whatever occurred in California had fallen through and that David no longer had any agreement with any production company. She stated that was a big hit to David because the production of the movie was his whole life. She stated during the course of that time frame she also noticed a change in Komel, she stated that David had always professed an anti-government type point of view and that her sister had started to come with the same type of view point and that she advised me that she had joked to David at one point during the summer; what have you done with my sister? She has changed. According to Sidrah she felt that David had all the power and controlled her sister.

Sidrah told me that in October of 2014 David called her father and in the conversation was swearing at him and advised him that they were no longer allowed to contact the family and that they were to leave the family alone. Sidrah stated that she called David and attempted to discuss what was going on up in Minnesota and he advised her also not to contact the family moving forward. Sidrah stated she attempted to contact Komel several times after her conversation with David but Komel would not return her texts or calls. Sidrah stated that it was decided that she would drive up to Minnesota to try and find out what was going on. She stated according to her records she arrived in Minnesota on 10-19-2014. Sidrah stated she had stopped by the Apple Valley Police Department to discuss a possible escort to the residence however, she was advised that based on her information that she provided to the officer it was felt that the matter was civil and that we could not offer assistance at that time. However Sidrah stated that she was advised by the officer that when she arrived at the residence if issues did arise that she could certainly call 911 and we would offer assistance at that point.

At that point Sidrah also advised me that back in May 2014 her father had allowed David and Komel to bring up his Acura passenger car so they could use that to get around since they needed a vehicle. Sidrah stated that her father helped them financially with the vehicle and that he just simply had asked them to handle insurance matters with the vehicle. She stated it was to her knowledge that David and Komel did not follow through on their end of the deal regarding the Acura and that part of her plan was to go up to Minnesota to take the Acura back to [REDACTED] Sidrah also stated that she had driven a Toyota passenger car to Minnesota that she had borrowed to her sister, Komel, to assist her while they were in [REDACTED] It was her plan to give her sister the Toyota and take the Acura back to [REDACTED] Sidrah stated that upon her arrival at the residence on Ramsdell Drive, David came to the door to speak with her. She stated that he appeared very skinny, his hair was disheveled and she

stated in her words "looked crazy". Sidrah stated David would not let her in to see her sister. He told her to go to her car and he would come out to speak with her in the driveway. She stated David went out the vehicle and advised her again that they did not want contact with her or her family. He stated that he along with Komel felt that they were treating Komel's mother inappropriately and there was some type of shady dealings going on with the situation down in [REDACTED]. Sidrah told David that they were welcome to call the hospital and speak with their mother and hospital staff to find out that they were not doing anything inappropriate. David told Sidrah that she could have the Acura however she had to leave the residence and come back in approximately an hour and the vehicle would be made available to her. David said however that she had to take both the Acura and the Toyota back with her to [REDACTED].

Sidrah advised me that she waited an hour and came back to the residence where she located the Acura parked in the street. She said she transferred her items from the Toyota to the Acura and left the Toyota in the driveway of the home. Upon getting into the Acura she observed a picture on the driver's side of the car. The picture was of her, her mom and her sister on the back portion of the picture was a note staying I will always love you and mom and she signed the picture Komel. Sidrah stated she felt something was wrong with what was going on but drove back to [REDACTED] to advise her family of her findings.

Sidrah stated approximately a week after returning home to [REDACTED] she discussed the matter with her father and they were both upset for how they were being treated by David and Komel. Sidrah stated that her father had been paying for both David and Komel's cellular phone service. It was decided at that point that phone service for both of them would be cut off. They stated they cut David's off completely and limited Komel's phone service.

Sidrah stated that they did not have any other contact with David or Komel form October 2014 until notification of the incident. However Sidrah did state that she did have 2 missed calls on 12-23-2014 from an unknown number. The first call was at her work on the morning of 12-23-2014 at 9:36am. The second call was at 11:40am. Sidrah stated she had no viable proof that the calls were from her sister but she believes that they were.

Sidrah asked that I only contact her directly regarding the incident. She stated her father is under a lot of stress due to what is going on with her mother and she felt that it best that she be the go-between between us and her father. I advised Sidrah that I would work with her on a daily bases to provide her updates and that she could contact me if she had any questions or concerns about the investigation.

## STATEMENT

On 01-17-15 (Saturday), I was called in to assist on the discovery of three bodies at a residence in Apple Valley. Upon arrival I was briefed on the situation and told that the bodies were believed to be of a man, woman, and child and were found at 1051 Ramsdell Drive, after a neighbor had called 911. The neighbor had become suspicious when another neighbor asked about the whereabouts of the residents from 1051 Ramsdell Drive. One of the neighbors, Prochnow, went to the residence and after getting no answer at the door, looked in the front window of the residence, which is a picture style window with the curtains open. Prochnow saw what she described as three dead bodies inside the house with a gun near the bodies.

Prochnow then called the police and reported the incident. Officers responded and found the rear sliding glass door, unsecured. They entered the house and cleared it, finding nobody in the house, other than three deceased people in the living room of the house. They then backed out of the house and secured the scene. It was at that point that I along with other Apple Valley Police Department Detectives were called in to assist with the investigation.

I assisted in preparing a search warrant to gain entry into the house to allow further investigation. After preparing the warrant I presented it to the Honorable Judge Karen Asphaug. The warrant was signed on 1-17-15 at 1506 hours. It had previously been arranged that the Bureau of Criminal Apprehension (BCA) Crime Scene Team was called out to assist in processing the scene.

I responded to the scene and met with the Lead Crime Scene Team Investigator, Joe Cooksley, and Special Agents Chris Olson, Michael Phill, and others. After briefing them on the scene and incident Cooksley, Crime Scene Technician Beth Wolf, SA Olson, Detective Booth and I entered the house at 1651 hours. As we approached the house I could smell a strong odor, which from my training and experience is known to be from decomposing bodies. As we approached the rear door to the house I noted that there was not any damage to the lock or anywhere on the door. This was the same rear sliding door that was reported to have been unsecured at the time of officers arrival. We proceeded into the house and completed a slow walk through to determine what evidence might be present. I

immediately noticed that there was a great deal of what appeared to be dog feces on the floor, and throughout the residence. I had previously been told that a dog was found to be inside the house when responding officers arrived at the house. It appeared that the families dog had remained in the house after the three people died. It appeared that the dog had free run in the house since their time of death.

As we got near to the living room I was able to see three bodies in the living room area, as had been previously described to me. The bodies were in an advanced state of decomposition. The bodies were all lying in close proximity to each other and were obviously deceased, based on their advanced state of decontamination. I noted that two of the bodies were missing their heads. It appeared that the two adult sized bodies did not appear to have heads or skulls attached to them. I also noted the male body did not have a left hand and the female body appeared to be missing one hand also. It appeared as though the dog had fed on the heads and hands of both adults. We also found a great deal of blood and hair debris in the kitchen living room and hallway area. Due to the lighting in the house and not wanting to disturb any evidence we suspended a detailed search of the house until the BCA Crime Scene Team finished processing the scene. The BCA Crime Scene Team processed the scene in detail and completed a property sheet for all of the property and/or evidence they collected from the scene. See that property sheet, which is attached to this case file for more information.

Detective Booth and I collected the mail from the mailbox at the residence, which was numbered the same as the house (1051). I first photographed the mailbox and mail contained in it and then collected the mail as evidence. We also noted there was one Thisweek paper in the newspaper collection area underneath the mailbox, which appeared to belong to this address. The paper was dated January 2, 2015. Once the mail was collected we sorted through the mail to try to discern the last time the mail was picked up. The majority of the mail in the mailbox was bulk mail without individual post marks or addresses. The mail that was specifically addressed to this residence was addressed to either David or Komel Crowley or both of them. The one individual piece of mail that was located was a hand addressed letter to "Mr. & Mrs. David Crowley & Ronny" at this address. The letter was post marked on 12-29-15 in St Paul and had a return address or "Crowley, 3450 Willow Ave., White Bear Lake, MN 55110". This letter was opened and we found a Christmas card in the envelope. The card was from David Crowley's grandfather. Photos were taken of the mail and all of the mail was collected and processed and eventually packaged as evidence.

Detective Booth and I later photographed the front step area of the home. On the front step were two wrapped Christmas presents, a brown paper bag, which was stapled shut and a bundle of paper shooting targets (unwrapped). We photographed each individual present and package and collected them as evidence. They did not appear to have been opened or tampered with. One present was addressed to "Raniya" and was from "Uncle Danny". The other present was to "Raniya/Rani" and was from "Grandpa". At the time they were collected it was unknown when these presents were left at the house.

It is believed that the residents at this house are a David Crowley, Komel Crowley and their daughter, Raniya Crowley.

The Hennepin County Medical Examiner was called to assist in the investigation of the deaths and to assist in removing the bodies from the scene. When the medical examiner entered the scene I accompanied them and took more photographs of the bodies as they were examined and moved. The following was found:

Body #1: Male adult, in an advanced state of decomposition with the majority of his head missing and only the back part of his skull still in place. The males upper spine was also exposed. His left hand was in place while his right hand was missing. The male was clothed, but was barefooted, and wearing pants and a shirt. The male was found lying on the floor of the living room with the top of his body facing to the East and his feet facing toward the West. The male appeared to be on his back at the time of our finding him.

Body #2: Female adult, in an advanced state of decomposition with the majority of her head missing. Only the back lower part of her skull was still in place. Both of her hands were found to be missing. The female was clothed, wearing heavy socks, pants, a corset, and shirt. The female was found with the top of her body facing toward the West and her feet facing toward the East. She was lying on her stomach at the time of her discovery. Her feet were spread apart and the body of the 3rd person (believed to be a child) was lying partially between her legs.

Body #3: Female child, in an advanced state of decomposition with her entire right arm and shoulder socket missing. The body was found on her left side with her head facing to the Northeast and her feet facing to the Southwest. The body was clothed and wearing sweatpants and a sleeveless or short-sleeved shirt.

All 3 bodies were examined and removed by the medical examiner, Dr. Jessica Lelinski and medical examiner investigator, Gregg Spandl from the Hennepin County Medical Examiner's office. It should be noted that Dr. Lelinski examined the bodies and found what she initially reported were possible gun shot wounds to the heads of all three bodies. Once the bodies were removed the scene was further processed by the BCA crime scene team. The crime scene team found a total of six empty spent cartridges (40 caliber), which were believed to have come from the gun that was found at the scene. All of the cartridges were a Winchester brand 40 Smith & Wesson cartridge. The Crime Scene Team also found three bullet fragments in the carpet in the area that the bodies were found. See the BCA report for further details as to where the spent cartridges were found.

A gun was found on the scene. The gun that was located on scene was a Springfield XD 40 caliber black semi auto pistol. The gun was found on the left side of the males body (to the south), by approximately 1 foot. The gun was loaded with a round in the chamber and a magazine inserted into the gun at the time of its discovery. The caliber of the gun and the cartridges on scene were a match. In looking at the scene we also discovered a possible hole in the downstairs ceiling and wall, which appeared to originate from the upstairs living room. After the scene was processed we were able to move the rug that the bodies were found on. The Crime Scene Team then located a hole in the floor which was consistent with a bullet being shot into the floor, from the living room and traveling through the floor and the suspended ceiling of the basement underneath the living room. After going through the ceiling the bullet entered the south interior wall in the basement and lodged in the wall. The Crime Scene Team was able to collect the bullet from the wall as evidence.

While the BCA crime scene team was processing the scene they found blood and what were believed to be partial fingerprints on the keyboard and surrounding surfaces of a laptop computer that was sitting on the kitchen island which is directly adjacent to the living room area where the bodies were located. The laptop was found in the open position (top up) and running and plugged into a wall socket. When the crime scene team attempted to swab the keyboard for a DNA sample the computer woke up out of a sleep mode with a blank screen to show a message in a TextEdit window on the MacBook laptop reading "I have loved you all with all of my heart". I photographed the message. I was not certain if this note was saved or otherwise date or time stamped. The note was not signed and was in the format of a typed note. In the background (behind the TextEdit window of the laptop) we found iTunes was running on what appeared to be a continuing loop of music. No music was sounding from the computer or any other speakers. We did find a Bose Bluetooth wireless speaker on an end table in the living room. It is believed that the speaker may have run out of batteries or charge and was no longer functioning which cause no music to be heard at the time of our being on scene. Also located on the kitchen island was an iPhone with blood on it. The blood was swabbed for DNA purposes. Below the iPhone, on the floor, were what appeared to be bloody footprints from bare feet. The only body on scene that was barefooted was the male body.

The BCA crime scene team assisted in examining the rest of the house including the master bedroom and upstairs office where they collected evidence from. In the master bedroom area they swabbed the gun safe, which was found to be on the right side of the bed. When we found the safe it was in the open position with the front panel of the safe lying open from a bottom hinge position. The safe appeared to be opened with four touch pads on top of the safe where the owner would put their fingers to gain access to the safe. The BCA swabbed the opening lock for DNA purposes. As I viewed the contents of the safe I noted that there was a loaded hand gun magazine and keys still inside the safe. There was not a gun inside the safe at the time I viewed it. It should be noted that the gun found in the living room would fit in the safe.

The BCA also processed the office area which was across the hall on the main floor of the residence. The office was set up with a couch and desk area in it. On the main desk area was a desktop Apple computer. In front of the keyboard for the computer was a spiral style notebook with the spiral hinge on the top of the notebook. The notebook was opened with a sheet of paper turned over from the top of the notebook with a blank back exposed to our view. On the bottom main portion of the notebook was another piece of paper with a handwritten note written on it. The note read from top to bottom open "The Rise" "most recent version". Below that writing was [REDACTED] it appeared that there was dried blood on that lower portion of the notebook adjacent to the writing. The dried blood was on the left-hand side of the handwritten note. And one of the spots of blood it appeared there was some ridge detail from some sort of latent print. The BCA collected that note and spiral notebook as evidence. I was able to photograph the note and notebook prior to it being collected as evidence.

After the BCA was done processing the scene they allowed detectives from the Apple Valley Police Department and Dakota County Sheriff's office to come in the scene and process the scene further. Detective Klokonos, Detective Olson and Detective Thomas (members of the Dakota County Electronics Crimes Unit) assisted us in processing the electronics found in the residence. The MacBook laptop, iPhone, and a kindle tablet were collected from the kitchen island area as evidence. They also collected the iPhone from the master bedroom dresser as evidence. They also collected numerous hard drives and an Apple computer from the office area on the main level of the house. A

Surface Pro Tablet was collected from the living room area, adjacent to where the bodies were found. All of these items were packaged as evidence and directly transferred to the Dakota County Electronic Crimes Unit, to be further processed and examined (after warrants were obtained for the items).

Detectives McKnight, Booth, Tietz, and Detective Sgt. Gummert assisted in processing the scene and collected numerous pieces of property and evidence from the scene which were placed into the Apple Valley Police Department property system as evidence. I photographed all of the items prior to collecting them. I also assisted in searching the house and found the following items in the house and/or assisted in the collection and packaging of these items:

AV - 1 Mail from Mailbox

AV - 2 Presents from front step, wrapped from "Uncle Danny"

AV - 3 Brown Paper bag from front step with presents and cards

AV - 4 Present from front step, wrapped from "Grandpa"

AV - 5 Bundle of assorted shooting targets

AV - 41 Medical records for David Crowley

AV - 42 iPhone from master bedroom dresser

AV - 43 Gun Safe from master bedroom

AV- 44 Magazine from safe, loaded with 11 rounds of ammunition loaded

AV - 45 Surface Pro Tablet (Computer) found in living room

AV - 46 40 Caliber ammunition from the trunk of Crowley's car - 50 rounds in a 50 round box

AV - 47 Gun case for a Springfield hand gun - Found chained to the trunk lid of Crowley's car

Several guns were collected for safekeeping as the house was going to be vacant. These guns were also placed at the Apple Valley Police Department for safekeeping and are authorized to be released to the proper next of kin. See the Apple Valley property Receipt, Inventory and Return form for more details about what was collected and removed from the house.

At the conclusion of processing the scene we left a copy of the receipt of property taken by the BCA and the Apple Valley Police Department as well as a copy of the warrant at the residence. The house was secured and the scene was cleared. Detective McKnight took photos of the exterior of the house prior to our entering the house and before it got dark outside. I took the remaining photos in this incident. All photos were downloaded to a secure server at the Apple Valley Police Department. It should be noted that the medical Examiner assigned three different case numbers to their investigation and are are follows:

On 1-18-15 I went to the Hennepin County Medical Examiners Office and observed the autopsies of David Crowley, Komel Crowley and Raniya Crowley. I assisted in trying to positively identify Komel using a Facebook photo of her, where she is seen to have a tattoo on her left wrist of a heart with the words "All you need" inside it. The same tattoo was found on Komel's left wrist during the autopsy. During the autopsy it was part of the preliminary investigation that it appeared that Komel been shot in the head twice. It appeared that the gunshots were to the back of her head. I also viewed Raniya's autopsy. During that autopsy they found a single gunshot wound to her head. What appear to be bullet fragments were also removed from Raniya's head.

I later viewed David's autopsy. I showed Hennepin County Medical Examiner, Dr. Jessica Lelinski, photographs of David Crowley's tattoos on his left forearm and right shoulder. Both tattoos matched David's tattoos at the autopsy. During the autopsy Dr. Lelinski found what is believed to be a gunshot wound to remaining part of David skull.

The photos used to aid in the identification of Komel and David were forwarded to the Hennepin County Medical Examiner's office and were also added to this case file. See the medical examiner's report for more details regarding their findings.

On 1-19-15, Detective McKnight and I met with David Crowley's family to gain information about David and Komel's relationship and the circumstances surrounding David, Komel, and Rani's deaths and to answer questions for the family.

During the meetings I learned that Daniel Crowley had dropped off Christmas presents and packages at the Crowley residence on 12-28-14. He left the presents on the front step and did not make contact with the family. He said he saw the dog come to the window of the front of the house, but left shortly after that, not wanting a confrontation with David. David said he did not look into the window at anytime and did not see the family during his visit.

See the timeline provided to us by Danny Crowley and Detective McKnight's report for more information.

On 1-20-14, Detective Tietz and I retrieved the property seized during the execution of the warrant, from the Apple Valley Police Department property room. All property seized was place in our property room until it could be entered into our property system, with the exception of items:

AV - 6AV - 7AV - 8AV - 9AV-13 to AV-35AV - 37AV - 42AV - 45

All of the above items were electronic in nature and were collected with the assistance of the Dakota County Electronics Crime Unit (ECU). All items of these electronic items were collected and turned over directly to the ECU for further processing and examination.

Detective Tietz and I further processed all of the other property which remained at the Apple Valley Police Department. Item AV - 2, was unwrapped and found to be a toy. Item AV - 3 was opened and found to contain mail for David Crowley which had been delivered to his father's residence, a hand addressed envelope for David and Komel, a flashlight, and a wrapped present from Al and Sue, which was an artist Journal for Raniya. The hand addressed envelope for David and Komel contained a \$14,000.00 personal check issued from David's father to David. Item AV - 4 was a present from Daniel Crowley Sr. to his granddaughter "Rani", which contained a world map.

All items that had not been previously photographed in detail were photographed and all items were packaged as evidence and entered into the Apple Valley Police Department property system. All items were placed into Apple Valley property with the exception of the items that were turned over directly to the Dakota County ECU. Photographs of these items were later downloaded to secure server at the Apple Valley Police Department.

At approximately 1300 hrs. on 1-20-15, Detective McKnight was contacted by the company cleaning up the Crowley residence at the request of David's father. The cleanup crew personnel notified Detective McKnight that they had discovered a bullet at the residence. They relayed to Detective McKnight that while picking up the rug from the main living room area a bullet had come out of the carpet and fallen to the floor. They were uncertain exactly where the bullet had been on the carpet, but said that it had fallen out of the rug and onto the adjacent hardwood floor. I responded back to the scene where I assisted in collecting the bullet that was discovered. I photographed the area finding that the crime scene cleanup crew had cleaned up the residence. I found that the bullet was lying approximately 1'10" from the west wall of the living room and approximately 3'1" S. of the corner wall, which leads to the dining area of the residence. We photographed the presence of the bullet with a ruler in place and then collected the bullet into a manila envelope. The bullet was later sealed as evidence and placed into the Apple Valley Police Department property system. That bullet will be transferred to the BCA crime lab for further analysis. It should be noted that the bullet was predominantly flat on the back and was sitting on the front/mushroomed portion of the bullet. The bullet appeared to be mostly intact at the time of our discovering it. The photographs of the bullet were later downloaded to a secure server at the Apple Valley Police Department.

On 1-20-2015 I spoke to a Heidie JoAnn Lish DOB: 3-30-1976 via phone at approximately 2:45pm. The phone number Heidie contacted me on was: 612-245-0699.

Heidie advised me that she was friends with Komel Crowley through a dietician's network. She stated that they got together often for coffee or at times to go out for the evening. She stated they got together regularly in the spring of 2014, she said the times they got together diminished as the year went on. She did state that she talked to Komel approximately 2 times via phone in August. She stated in September they did not have any meetings or discussions over the phone.

Heidie stated in October Komel began pulling away from the relationship. She stated she quit her job at the eating disorder clinic called Melrose at Methodist Hospital. Heidie said that although she would get back to her via text in October it became more and more inconsistent and that she started to talk about things she hadn't discussed in the past. Heidie gave an example of Komel talking about moving to California wanting to start her own dietician practice.

In November 2014 Heidie advised me that Komel told her that she was quitting dietician work and was working on writing a book on eating disorders. Heidie stated that Komel agreed to meet with here on November 24th, 2014 for coffee. Komel again reiterated to Heidie that she was going to quit being a dietician and open a business with David Crowley. During the coffee meeting Heidie said Komel was not terribly open with her, she stated that Komel appeared to have no energy and told her that she would go weeks without leaving the home.

Heidie advised me that after the meeting on the 24th she would text or talk to Komel periodically on the phone. She exchanged text messages with her on the 3rd of December and advised me that the last text message exchange would have been on Sunday December 21st, 2014 at 8:13am. Heidie sent me screen shots of the text messages she had with Komel in December, those screen shots were scanned into the case file.

I asked Heidie if Komel had ever talked to her about her relationship with David and or her child, Raniya. Heidie stated she felt that Komel didn't always seem connected with Raniya. According to Heidie, Komel confided in her that she didn't always enjoy being a parent and that it was challenging. According to Heidie, Komel told her that they had to take care of Raniya but advised she didn't want

other kids. Heide advised me that she did not mention much about David, what she did state that all of his movie work was for an upcoming Spiderman movie that he was making.

Heide had no other information for me regarding her relationship with Komel. The conversation I had with Heide was recorded on my Olympus recorder and downloaded to a secure server at the Apple Valley Police Department.

## STATEMENT

On 1-26-15, I attempted to locate the residents at 1066 and 1074 Lowell Drive in Apple Valley. Both of these houses directly border the Crowley residence. I spoke to Gena Arlouiene Olson(6-20-68) at 1074 Lowell Drive. She said that her husband, Alan, believes he had heard three rapid fire shots from somewhere outside their residence. She said that Alan could not remember exactly when he heard the gunshots. She said that they had discussed what he had heard after discovering what had happened at the Crowley residence, which is located to the southeast of the residence. Gena said the gunshots had occurred sometime before New Years Eve and possibly happened around Christmas time. Gena said that they had not called the Apple Valley Police Department to report what they had heard.

On 1/27/15, I spoke to Alan Olson regarding his observations and what he had heard. Alan said that he had not seen anything suspicious at the residence. He said that one evening he heard what he thought to be several "rapid fire" gunshots. He could not say where the gunshots came from or when they happened. Alan said that he had been trying to think of more specific information about the gunshots. He said that he had been in the living room of his residence with his daughter when he heard them. He said he mentioned that out loud to her, at the time he heard the noises. Alan said he believed that that had happened sometime before New Year's eve. He could not say that it happened on or around Christmas day. Alan explained that he and his family had been home on Christmas day until approximately 1300 hours. He also said he had been home Christmas Eve from approximately 1300 hours and then after. He was uncertain if either of these days was when he had heard the gunshots. He could not say if the gunshots happened before or after one of these days. Alan was certain that he had heard what he believed to be three rapid fire gunshots at that time. He believed that it had happened in the evening hours. Alan explained that he had not called the police because he did not have any specific information about when he had heard the shots.

On 1/27/15, I spoke to the resident of 1066 Lowell Drive, Theresa Shepherd. Shepherd said that she had been out of town until 12/23/14. She said upon returning home she found that there were no lights on at the Crowley residence. She believed that there were not any lights on and thought they might have been on vacation. At one point she noticed that the rear sliding patio door was standing partially open. She said from her vantage point she could not say if it was the patio door or the screen door that was standing open, but she could see a door was ajar at the rear patio door area. Shepherd was uncertain as to when the door became ajar but believed it was shortly after she arrived home from vacation. Shepherd did not hear or see anything else unusual at the Crowley residence. She said since the incident has come to light, she said there was a lot of activity at the residence on

On 1-26-15, I spoke to the circulation coordinator for the Thisweek Newspaper, Kathy Silberg (952-840-2070). Silberg said the Apple Valley issue of the Thisweek paper dated December 26, 2014, was actually published and printed by before that date. This issue of the Thisweek paper was found in the kitchen garbage can in the Crowley residence, during the execution of our search warrant for this incident. She said the papers were delivered for pickup by the delivery drivers on 12-24-14. Silberg explained that the papers are left at a centralized location for the delivery drivers to pick up and then deliver. Silberg said the papers could have been delivered on December 24, 25, or 26. She said the deliveries for 1051 Ramsdell Drive are part of "AV9 Route". Silberg identified the delivery driver as [REDACTED], who is a teenager.

On 1-26-15, I went to [REDACTED] house and spoke to his mother, [REDACTED]. She said [REDACTED] had delivered the Thisweek paper on 12-24-14. She was not certain about what time he would have delivered the paper.

It should be noted that the Thisweek paper dated 1-2-15 was found at the outside mailbox for this residence. According to Silberg that issue of the Thisweek paper was actually made available for delivery on 12-31-14 and could have been delivered on 12-31-14 or 1-1-15 or 1-2-15.

**STATEMENT**

On 01/17/2015, I received a page from dispatch informing me that all investigators were being called in to investigate a suspicious death. When I arrived I coordinated with Detective Bone. I learned that he was writing search warrant for the address 1051 Ramsdell Drive. He informed me that patrol officers had found three victims on the living room floor. There was a gun near the bodies. The assumption was that they had all died of gunshot wounds. Their bodies were in an advanced state of decomposition.

I assisted with the search warrant and then contacted the Hennepin County Medical Examiner's Office. I informed them of what we had told them that we had also contacted the Minnesota Bureau of Criminal Apprehension Crime Scene Team. The on-call medical examiner's investigator told us that they would wait until BCA was ready before they responded to the scene.

I arrived at the address and took overall pictures of the exterior the house. I focused on all entry points including doors and windows. There was no sign of forced entry however I had heard that the patio door was left unlocked and opened less than an inch. I noted that there were several sets of footprints in the backyard. I was told that it was a dog in the house and that the dog ran out of the house and had to be captured so it would not get away. Officers had to chase the dog in the backyard and left footprints. According to all of the responding officers there were no footprints in the backyard when they first arrived and all of the footprints belong to them.

While waiting for the Minnesota BCA and Medical Examiner's Office to finish their work inside, I was assigned to background work on the family. I was able to find a number of website and social media references to David Crowley and his wife, Komel Crowley. This included movie trailers for the Gray State: The Rise. There were also Facebook sites and other social media related to the two of them. Preservation requests were sent to Facebook and Twitter to ensure that the sites could be recorded as they were that evening.

After the medical examiner and BCA were finished, I entered the home with the other Apple Valley Detectives. We were also assisted by Detectives Jacobson and Olsen with the Dakota County Sheriff's Department. We collected all items that appeared to be of evidentiary value. This included numerous computers, hard drives, laptops, cell phones and other digital media storage devices. It was believed that these items may help us to re-create a time line for the events and potentially provide a motive or mindset leading to the death of the three people in the house.

My role throughout this search warrant was the documentation and packaging of the items taken. These items were all included on the receipt inventory and return which will be filed with Dakota County. Copies of the receipt as well as a search warrant are left at the scene.

These items were transferred directly to the custody of Detective Klokonos to be brought back to the electronics crimes unit offices. Detective Klokonos, Jacobson and Olsen would be doing forensic examinations on these items.

Later that same morning I attended the autopsies of Komel Crowley and her daughter Raniyah. Although I did not stay for the entire autopsy the initial belief of the medical examiner was that each died from a gunshot wound to the head.

I obtained a search warrant for the forensic examination of all digital media that was signed by the Honorable Judge Karen Asphaugh. This warrant was forwarded to Detective Klokonos prior to anyone beginning a search of the media.

Medical examiner was able to positively identify the deceased. Based on this identification I contacted the Crowley family including his father Daniel Crowley and mother Kathryn Crowley. I explained to them all what I knew at that time and arranged to meet with them the following day.

On 01/19/2015 Detective Bone and I met with Daniel Crowley at his home. I also met with his other two children, Daniel (DJ) and Allison Crowley. They explained to me that David and his wife Komel had distanced themselves from the family since mid-October. There did not seem to be a reason for this other than that Komel had told Allison that they were going through some personal issues and were going to work it out alone as a family. With the exception of one email there was no apparent anger or discord in the family. Even the email that was somewhat more tense was not harsh and did not give specific reasoning for wanting to cut off ties. All three stated that David and Komel were almost of one mind and may have seen their situation as them against the world. They felt that they loved each other and were having a hard time grasping what could have driven David and/or Komel to do this.

The timeline was put together collaboratively and sent to me by email by DJ Crowley. The timeline is been attached below:

7-7-14 David's Birthday - everything good

7-20-14 Everything going well! Working on the house and keeping real busy

8-10-14 Raniya Birthday - everything normal. They thanked me for grilling at Raniyas party and David said "Love you dad"....which was strange I guess.

8-13-14 David also wanted to pick a weekend to go camping in Duluth.

8-?-31 DJ talked to David on the phone. Was supposed to baby-sit. Last time DJ and David spoke

8-30-14 I ask them to come down to visit as DJ will be there too.

8-31-14 They declined as they were too busy. I asked if he was ok. I tell him he sounds stressed and ask if there is anything I can do to help. He says no, nothing out of the ordinary.

Bullet Exchange garage sale

9-6-14 I ask if they want to come down to grill. He says they were busy cleaning up after a big garage sale they had.

9-2014 – DJ and Komel correspond regarding possible job opportunities

9-21-14 I took Raniya to zoo. Last minute he tried to discourage me from picking up Raniya. He was busy working on the house. The weather looked funky. I picked her up anyway. After the Zoo I stopped in to talk. He was about to make a big movie deal. Talked about big shot lawyers from the IDS building he was going to fly to LA to do final negotiations with the producers. He was going to be a millionaire by the end of the year.

They were busy and didn't seem like they wanted me to hang around so I left. That was the last time I saw David.

Al- I've been nothing but patient and polite in my email exchange with you, but it appears as though you're mistaking my generosity for ignorance. Here is the answer to your question: please go back and read the email you sent to my husband *on my birthday*. READ IT. Carefully take in each word that you accused him of, and imagine your brother's face and if you have any God forsaken love left for him, you will be forced to imagine the face that cried to you trying to show you his heavily burdened heart back in August.

We're not kids anymore. Take some responsibility for your words and stop pretending your fuck ups are forgotten by others just because your mind has chosen to get over it.

Later I met with David's mother, Kate Crowley. Her daughter Allison came to her house as well. Kate informed Detective Bone and I that she had not seen David, Komel or her granddaughter since the birthday party in August. She is not spoken with them either and had concerns because they changed their phone number. She had no insights into what they had done or why they had done it. She said that the one thing she was sure of what that David and Komel loved each other and that they loved

their daughter. She had trouble believing that David would do anything to harm his family without Komel being in agreement with him.

Since these meetings I've worked with the family on a number of issues including getting the dog that was found in the house to DJ. They also asked that I work with the Bio – Tech crime scene cleanup team and escort them into the house.

I was contacted by the cleanup team while they were in process. They stated that they had located a bullet that had been rolled up in the carpet. The bullet had rolled out under the hardwood floor that it already been cleaned. I went to the house and assisted Detectives Bone and Booth in collecting the bullet.

The house was secured by the cleanup team. Later I was contacted by Dan Crowley. He request that I enter the home and find an insurance card in the car. He was attempting to find the homeowners insurance so that he could give the policy number to the cleanup company. He was hoping that the homeowners insurance was the same as the auto insurance.

Throughout this investigation I talked to a number of individuals who have reported to be friends and associates of David and Komel. These include Sean Wright, Jeff Miner, David West and Jason Allen. All of these people were involved with David in the production of his movie. All of them told me that while David's movie could be seen as anti-government, David's views may not have been as strong as the movie would lead one to believe. They also stated that although within the online antigovernment community conspiracy theories about the crime were running rampant they did not believe that this was anything more than a horrible tragedy involving only David, Komel and their daughter.

I will include copies of the emails in the case file. Do not have full name and date of birth for several of these people. Some of these people were reluctant to provide full information. However if they need to be contacted in the future, I have enough information to find them.

Detective Klokonos advised me that there was activity on the Crowley's account on 12-25-15. I presented the warrant to the Honorable Judge M. Mayer and he signed the warrant on 2-2-15 at 1413 hours. It should be noted that on 1-30-15 I sent Dropbox.com a preservation letter for crawls04@gmail.com. A copy of the letter and warrant have been added to this case file.

A warrant was prepared for both Komel's and David's financial records (credit report). The warrant was written to AAA Credit Screening, which is a company that prepares credit reports for individuals. I presented the warrant to the Honorable Judge M. Mayer. He reviewed the warrants and signed the warrants on 2-2-15 at 1413 hours. On 2-2-15, I asked Sergeant Gummert to send these warrants to AAA Credit Screening, which he did via Email.

On 2-17-15, I spoke to Christopher Peter Klien (4-18-83), who identified himself as a friend of the Crowley family. I had been trying to locate Klien to learn why he had been at the Crowley residence on 1-19-15, as a neighbor had called in about a suspicious person at the house. Klien received my business card at his residence and called me back at approximately 1700 hours on 2-17-15. Klien wanted to ask me questions about the status of this investigation and was speculating about how many rounds had been discharged at the house. He indicated to me that he had been in the house since the discovery of the Crowley family at the residence. He said he had been there with David's father and brother and had seen there were two shot rounds in the "floor" and "roof".

(Sr.) and obtained permission to go into the house. At approximately 1500 hours, Detective McKnight and I used the house key in the front door lock box to gain entry into the house. We immediately found what appeared to be a bullet hole in the ceiling near the front door and adjacent to the living room. From my initial looking at the hole in the ceiling it appeared that the bullet may have come from the living room area, based on the angle the bullet appeared to have traveled through the sheetrock. We looked for access to the attic area of the house and found that the Attic access from the master bed room closet was open. This had not been open at the time of our initial search of the house on 1-17-15.

I contacted the BCA crime scene team and advised them of our findings. I requested they assist us in documenting the damage and assist in looking for the bullet in the ceiling and attic area. We secured the house and Detective McKnight maintained security on the house while I obtained a warrant for the house. I prepared a search warrant for the house to recover the bullet believed to be in the ceiling or attic area. On 2-18-15 at 1625 hours, the Honorable Judge S. Moynihan signed a search warrant granting us access to the house to recover what was believed to be a bullet from the ceiling.

Detective McKnight and Tietz assisted me in executing the warrant with the assistance of the BCA crime scene team and Special Agent Olson with the BCA. The party giving Detective Bone the information was Christopher Cline. Cline reported to be a friend of the family and said he had been inside the home with Dan Sr. and Jr. and had seen the bullet hole then.

During the initial processing of the crime scene we knew that we could not account for several bullets that may have been fired from the gun used. The information given to Detective Bone could not be verified since we could not establish a definite connect between the reporter and the family.

I contacted Daniel Theodore Crowley 1962-03-10, the father of David Crowley. To our knowledge he is the next of kin in this case. He told me that he was not aware of the bullet hole and had not gone into the home with Cline. I asked for permission from Dan Sr. to enter the home to verify that there is a bullet hole. He agreed to let us in and provided us with the lock box code.

Detective Bone and I went to the home and found the bullet hole near the entry way in close proximity to where the Christmas tree had been. We exited the home and ensured it was secure. I waited in the driveway until Detective Bone could obtain a search warrant. He obtained a search warrant authorized by the Honorable Judge Moynihan. He also contacted the BCA crime Scene team to search for the bullet and document the scene.

Detective Klokonos and the DCECTF did not find any information on the related devices that showed motive or cause for what happened during or up to this incident.

All items seized and initially turned over to the DCECTF were returned to my custody on 10-6-15 by Detective Klokonos. All items were placed into property as evidence at the AVPD. A copy of the evidence report has been added to this case file. Detective Klokonos also provided me with a CD of all recovered data and reports regarding their analysis. The CD was placed into property at the AVPD.

On 10-6-15 I filed the above referenced search warrant with the Dakota County Clerk of Courts, along with the Receipt, Inventory and Return form.

With the conclusion of the review of the digital devices, there is no other information available for further investigation. Throughout this investigation the AVPD has not discovered any information or evidence that shows anybody but David Crowley is the perpetrator of these crimes, including the killing of his wife, child, and himself.
