I want to make sure we are on the same page here, apologies for the abbreviations:

1. There should be 3 LLCs: 1) HH Productions; 2) Gray State; 3) Gray State - The Rise. I did not form HH, LLC. I formed the latter two.
2. I am not named as an officer for any of the LLCs. I may be named as the "organizer", which is not an officer, but the
